- You're interested in improving governance and leadership and believe that good leadership can make a big difference.

- You enjoy working as part of a team, are confident in your own opinions and able to be part of collective decision making.
- You're open-minded, democratic, debate deeply and constructively, and are solutions-focused.
- You're keen to bring and use your professional skills and life experiences, and willing to be engaged and interested in all aspects of our work.

#### **Core Duties**

The Board currently meets remotely four times a year. Each meeting lasts approximately two hours. When face-to-face meetings are permitted, these take place in Cardiff and joining by video conference is always an option.

#### **Terms of Office**

The successful applicant(s) will serve for a three-year term, with scope to renew for a further three years. This is an unpaid role, however travel expenses are provided as required and any other costs associated with attending meetings or events will be covered by the charity.
